Answer no.1

According to the national law the payment can be proceeded only in national value (MKDenars), on base of issued invoice for implemented works.

The contract can be concluded in value different from MKD as well as tender financial offer. In case when the Contract is financed with EU IPA Funds we have to use EUR as value for financial offer under given call for tenders. Regarding this, the financial offer has to be in EUR.
